Terms and Conditions

All entrants must accept and comply with all the event terms and conditions. There will be no refunds to non-use of entry and entry fees cannot be transferred to future events. **Helmets are compulsory during the Event including practice.** Entrants must follow ALL aspects of the Snow Responsibility Code. It is the entrant's responsibility to ensure that any of their equipment used in the event is in safe condition to compete with. Entrants must comply with all directions of event officials, marshals and security personnel as well as all event signage. Ruapehu Alpine Lifts Ltd. reserves the right to change the course on event day for safety or weather considerations. It is each entrant's responsibility to ensure that they have adequately prepared themselves physically for the Event. Prior to participating, entrants will have the opportunity to inspect the course(s). Entrants agree that their first priority is the safety of themselves and others. Ruapehu Alpine Lifts Ltd. will not accept any liability for injury/fatality to any participant or damage/loss of property. All entrants are required to attend a competitors' briefing as posted in Competitor's Information on the day of the event. It is each entrant's responsibility to be informed and read all information made available regarding the event. Each entrant will accept that all instructions, whether written or verbal, are clear and unambiguous. Any entrant who, in the opinion of the organisers, fails to comply with these event conditions may be disqualified from the event; no refund will be granted. Entries will be accepted according to Competitor's Information; late entries may not be accepted. Competitors must pay a \$20 bib deposit at the time of registration, which will be refunded when the bib is returned.

Waiver of Rights
